- 3. That the Havasupai Tribe is entitled to immediate control of the Infringing Domain Names.
- 4. That FastDomain, Inc. is the registrar of the domain name havasupaifalls.net and, as registrar, FastDomain, Inc. has the ability to transfer ownership of havasupaifalls.net to the Havasupai Tribe.

- 6. That eNom is the registrar of the domain name havasuwaterfalls.com and, as registrar, eNom has the ability to transfer ownership of havasuwaterfalls.com to the Havasupai Tribe.
