**COUNTS ONE THROUGH FORTY-TWO**

**Theft by Officers or Employees of Gaming Establishments on Indian Lands  
18 U.S.C. § 1168(b)**

On or about the dates listed below, in the District of Idaho, the defendant, COLTEN NICHOLAS CURLEY, an employee of Coeur d'Alene Casino, a gaming establishment operated by an Indian Tribe pursuant to an ordinance approved by the National Indian Gaming Commission, embezzled moneys of a value in excess of \$1,000, to-wit:
