

STATEMENT OF PROBABLE CAUSE

On Friday April 5, 2019 at approximately 8:52 pm I responded to 903 Old Pecos Trail, Cliff's Packaged Liquor Store, in reference to a disorderly conduct. I was advised by the Santa Fe Regional Emergency Communication Center (RECC) that the owner of the store was calling in stating there was a female who was at the store attempting to buy liquor. RECC advised that the store refused to sell her liquor because they believed she was drunk. RECC advised that the female was sitting outside of the store in a gray in color Volkswagen SUV.

I arrived on scene and observed a gray in color Volkswagen SUV parked in front of the store bearing New Mexico license plate 429WKH. I observed a female sitting in the driver's seat of the vehicle. I approached the vehicle. The female in the driver's seat, later identified as Ms. Jenni Monette, immediately opened the door. Upon Ms. Monette opening the door I could immediately smell an odor of an intoxicating beverage on her breath and/or person. I asked Ms. Monette if she had been drinking. Ms. Monette advised she had not. I then asked Ms. Monette why I could smell an odor of an intoxicating beverage emitting from her breath and/or person and why her eyes were bloodshot and watery. Ms. Monette advised she had been crying. I then asked Ms. Monette what was going on this date. Ms. Monette advised she was denied service at the store due to discrimination. I asked Ms. Monette how they were being discriminative towards her. Ms. Monette refused to let me ask her any questions and became belligerent. I attempted to explain to Ms. Monette what my concerns were. Ms. Monette continued to be belligerent and refused to let me speak.

Corporal Jared Mosher arrived on scene and attempted to speak with Ms. Monette. Ms. Monette continued to be belligerent and refused to let Cp. Mosher speak to her. Ms. Monette then advised Deputies she would not perform any Standardized Field Sobriety Tests or a breath test. Ms. Monette was advised to turn around. Ms. Monette stated she would not turn around and started walking towards her vehicle. Ms. Monette refused and stated that she was not going to turn around. Ms. Monette was then placed in restraints behind her back. While handcuffed Ms. Monette continued to resist Deputies. Cpl. Mosher advised he reviewed security footage from the store and observed Ms. Monette drive up to the store, exit from the driver's seat and then enter the store. Ms. Monette was observed to be the sole occupant of the vehicle.

Ms. Monette was then transported to the Santa Fe County Adult Detention Facility. Once at ADF I read Ms. Monette the New Mexico Implied Consent Act advisory breath portion. Ms. Monette refused to submit to a breath test. Ms. Monette was then booked accordingly.
