4	THE COURT: Good morning. Please be seated.
5	THE DEPUTY CLERK: We have United States of America
6	versus James Dean Cloud.
7	Case number CR-10-2077-RMP.
8	Time set for revocation of supervised release hearing.
9	Counsel, please state your appearances for the record,
10:44am 10	beginning with the plaintiff.
11	MR. HERZOG: Good morning, Your Honor, David Herzog on
12	behalf of the United States.
13	And the probation officer is present as well.
14	THE COURT: And what?
15	MR. HERZOG: The United States Probation Officer is
16	with us as well.
17	THE COURT: Oh, okay. Thank you.
18	MR. RUBIN: Good morning, Your Honor, Daniel Rubin on
19	behalf of Mr. Cloud, whose here in custody.
10:46am 20	THE COURT: All right.
21	Good morning, Mr. Cloud.
22	MR. CLOUD: Good morning, Your Honor.
23	THE COURT: Mr. Rubin, how are we proceeding on the
24	allegations?
25	MR. RUBIN: Your Honor, Mr. Cloud is going to admit

1 all six violations. 2 THE COURT: Okay. 3 Mr. Cloud, would you and Mr. Rubin please come to the podium. 4 5 Let's go through the violations. So the first 6 violation is on a petition that was filed February 21st, 2017. 7 The condition was to abstain from the use of 8 controlled substances and apparently you used on February 14, 9 2017 and admitted that --MR. CLOUD: Yes. **10:47am**10 THE COURT: -- to your probation officer. So you're 11 12 admitting that violation? 13 MR. CLOUD: Yes, Your Honor. THE COURT: Okay. 14 15 I find violation number one has been committed. Regarding the second violation, that is on a petition 16 17 filed March 9th, 2017, concerning the same condition, to abstain from the unlawful use of controlled substances. 18 And apparently you admitted to smoking marijuana out 19 of a meth pipe on February 19th, 2017. **10:47am**20 21 Is that correct? 22 MR. CLOUD: Yes, Your Honor. 23 THE COURT: Okay. I find number two has been 24 committed. 25 Regarding number three, standard condition number 13,

1 to follow the instructions of your probation officer. 2 And on February 15th you were given a directive to begin weekly reporting on Mondays and you failed to report. 3 4 Are you, do you know the details of this one? You 5 were ordered to report on February 16th, 2017, and again on 6 Tuesday, February 21st. 7 You failed to report on the first day in question, but 8 you indicated that you had been ill and had slept most of the 9 day. Do you admit that you didn't report as ordered? **10:48am**10 MR. CLOUD: Yes, Your Honor. 11 12 THE COURT: Okay. 13 I find number three has been committed. Regarding number four, condition number six, that you 14 15 abstain from the use of illegal controlled substances and submit 16 to testing. 17 The allegation is that on February 28th, 2017, the probation office received notice from Adept that you had failed 18 19 to show up for your random UA. **10:49am** 20 Do you admit that violation? 21 MR. CLOUD: Yes, Your Honor. 22 THE COURT: All right. 23 I find violation number four has been committed. 24 Regarding violation number five, that's on a petition 25 that was filed April 21st, 2017, standard condition number five,

1	that you live at a place approved by the probation officer, not
2	change your residence without advance notice.
3	And the allegation is that on March 20th, 2017, the
4	probation officer was contacted by the owner of the transitional
5	house, saying that you had not been staying there.
6	Do you admit violation number five?
7	MR. CLOUD: Yes, Your Honor.
8	THE COURT: Okay.
9	Regarding violation number six, that concerns, that's
10:49am 10	on the petition May 24th, 2017, concerning that you not commit
11	another federal, state or local crime.
12	And on May 22nd, 2017, the allegation is that you were
13	arrested for having a concealed weapon and resisting law
14	enforcement.
15	Do you admit that violation?
16	MR. CLOUD: Yes, Your Honor.
17	THE COURT: Okay.
18	I find violations one through six have been committed.
19	You're in criminal history Category VI.
10:50am 20	The grade of the violation is a C.
21	The grade of the original offenses, a C.
22	Under the statute you could be sentenced to two years
23	in prison and supervised release of 34 months, minus custody
24	imposed.
25	Under the guideline the sentencing range is 8 to 14

1 months and 34 months of supervised release, minus any custody 2 imposed. 3 I understand that you have a letter. 4 MR. CLOUD: Yes, Your Honor. 5 THE COURT: Do you want to read it to me? 6 MR. CLOUD: Yes, Your Honor. 7 THE COURT: And Mr. Rubin, will you move the 8 microphone so it's in front of Mr. Cloud. 9 MR. CLOUD: Your Honorable Judge Peterson. I would like to apologize for standing in front of you yet again under **10:51am**10 such circumstances. 11 12 Please understand that I know I've been blessed with 13 the time in which I got to see my loved ones again. 14 And I must give thanks to Mr. Heinen as well. 15 In my experience, it is rare to come across a person who can be so patient with a man with my shortcomings -- oh --16 in his career or in his line of work. 17 Your Honor, I would like to thank you for that, most 18 19 of all. I tried to make it a -- I tried making a new start in a new city and I failed badly. **10:51am**20 I made it clear to my PO that Spokane was a big 21 22 trigger -- this is after being here awhile -- for me, but 23 regardless, I failed under my own free will. I will own that 24 loss of opportunity. 25 Your Honor, the whole time I was here I yearned to go

1 home, but when I first completed treatment, this place seemed 2 to, um, seemed so ideal. But I don't want to stay here, stay around here. 3 So I fled home and I lived with a woman who has 4 5 supported me for 14 years of prison time I sat and even 6 supported me before that. 7 As I lived with, as I lived with her for over two 8 months, I started feeling pretty low for not pulling my own or 9 pulling my weight financially. I had some childhood friends who now are co-owners of **10:52am**10 the King Mountain Tobacco Products and Wheeler Logging, but they 11 12 would not hire me until I finished up with my legal issues. 13 Your Honor, I tried the best I, the best that I could 14 and I would like to be done with being on paper. 15 I have a support group back home, but I don't believe I will succeed while I go or I got probation looking for me. 16 17 So please give me what time you must and let me and let me get on with my life. 18 19 I already have my state sentence to do, which is 23 **10:53am**20 months. I don't think I, I don't think I would have made it 21 22 trying to comply for two different probations, but I tried and I 23 know that I couldn't succeed. My DOC is done after this. Will you please consider 24 25 killing my paper and letting me go to a, go get a job back home

and live my life. 1 2 The closest office from where I will be living is over 20 miles away, so I don't believe I could successfully manage 3 4 probation. 5 Thank you once again for everything you have done. Ι 6 will be forever grateful. 7 Sincerely, James Cloud. 8 THE COURT: Can I call you James? 9 MR. CLOUD: Yes. **10:54am**10 THE COURT: Chris Heinen was sorry not to be here. He's actually at Sheridan helping some other people who are 11 12 getting into transition. 13 But he and I, and Tommy Rosser, a bunch of other people, have talked a great deal about what we could do with 14 15 your case. I disagree with a couple of things you've said. 16 I am 17 aware that because of the DOSA sentence you got that the state is revoking, Chris's understanding, you will be between 356 days 18 19 and 531 days detained by the state. MR. CLOUD: I get the 20 -- I had 24 or 25 months. **10:55am**20 Ι completed two, so I got 23 months left, which I get a third off 21 22 with good behavior, so that's 15 months. 23 THE COURT: Right. So that could be up to the 531. 24 MR. CLOUD: Yeah, if I can't behave, yeah. 25 THE COURT: So I appreciate that you, you know, felt

1 such a strong tie and you went to visit your friend and lived 2 with the woman, but then something went wrong. MR. CLOUD: I, I was taking out of the mouths of two 3 4 kids, I felt and -- meaning I couldn't pull my weight because I 5 couldn't find a job. 6 I did little odd jobs running up in the mountains and 7 getting wood. But I couldn't get a job while ducking, while 8 having warrants. 9 I couldn't drive. I'm able to go get my license, but I can't take the test. **10:56am**10 And if I bought a car, it would just get tooken (sic) 11 12 any time I got pulled over. 13 I was more or less a burden. I felt mainly it was the 14 shame, it was shame, you know what I mean? 15 THE COURT: Yeah, I know what you mean. But you're looking at this in a certain way. You tell 16 17 me that you failed and that you failed -- I actually don't see that. Chris and I don't see that. We see where you succeeded. 18 19 You had gotten a long sentence in 2010 or 2011, **10:57am**20 whatever I sentenced you. As you know, I didn't think it was a fair sentence. 21 22 There was a little window of opportunity for me before the 23 Supreme Court came down with a ruling and I opened that door and 24 let you out. Very purposefully. 25 In fact, the Supreme Court has now come down with a

1	decision that I wouldn't have had that ability to do that.
2	After you got out, you spent 57 days doing exactly
3	what you were supposed to do.
4	Then things got a little overwhelming. I didn't know
5	about the woman in Yakima. Maybe we could have arranged
6	something differently.
7	But then you got the revocation. Two months.
8	And then we modified and put you into treatment.
9	Then when you got out of treatment, you managed
10:58am 10	another 42 days of doing exactly what you were supposed to be
11	doing.
12	And one of the things is you got a job right away,
13	which was a good thing. But that maybe kind of changed how much
14	treatment we could provide you and how much other stuff.
15	So all together, by my calculations, since you got
16	out, not even a year ago, you got out September 19th of last
17	year, you've had 99 days of totally good behavior.
18	I think that's pretty terrific, actually, when you
19	consider the challenges that you've had and the lack of
10:58am 20	treatment that you've had and the fact that you've been having
21	to make your own decisions for so long without any structure,
22	without any help, with no tools in your tool box.
23	Now I don't doubt that you could go out and be able
24	to, you know, work either at King Mountain or whatever, but I
25	think you're setting up supervised release as a false barrier.

1	It isn't really going to be the barrier.
2	What's going to be the barrier is if you get out, you
3	get frustrated and you turn to alcohol, you turn to drugs, and
4	then you figure, what the hell, I'm already in trouble, you

6	Instead of taking that, okay, I'm frustrated, I'm
7	going to try this, or I'm going to try that or I'm going to call
8	this person.
9	Or, even if you do drink, or even if you do meth or
11:00am 10	something, saying, I'm going to pull out of this nose dive.
11	Okay, I screwed up this time. That doesn't mean I have to throw
12	away the rest of my life.
13	I know you just had a birthday and your birthday, what
14	was it, 34?
15	MR. CLOUD: Yes.
16	THE COURT: That's, you know, just about half my age.
17	And I can tell you, you have a hell of a lot of time ahead.
18	So, how do you want it to be? And I'm going to tell
19	you right now, you get to decide that.
11:00am 20	Not in some bizarre way, but I don't care what counsel
21	say, I know you better than they know you.
22	I'm going to give you three months tacked onto the end
23	of your state sentence. And I'm going to tell you why I'm going
24	to give you that three months.
25	Because you'll be over on the west side and what we

1 can do is have you held at Sea-Tac and put into treatment. 2 We're trying for Thunderbird, which is a Native American treatment program. 3 I've been there once before as a child. 4 MR. CLOUD: 5 THE COURT: You were there as a child? 6 MR. CLOUD: Yes. 7 THE COURT: Was it a good place? 8 MR. CLOUD: It is. 9 THE COURT: They have a program, if we can get you in, **11:01am**10 that would be up to 90 days. And drug treatment doesn't just miraculously, you 11 know, one time and you're cured, you know. It's not like 12 13 graduating from high school. It takes repeated times. It's a skill. You have to practice it in the same way you have to 14 15 practice shooting. It doesn't just happen. We would be able to, or we would try to -- and Chris 16 has spent a lot of time looking into options -- we would hope to 17 put you in a place where you could get the treatment for 90 18 19 days. **11:02am**20 We could then get you transferred to wherever. Ι 21 mean, if it's Yakima, fine, but Yakima has its triggers too. 22 You're telling me Spokane has its triggers, Yakima has a ton of triggers for you. Old friends, old enemies, family members, old 23 places, old haunts. 24 25 You know, it would be great if that woman can move. Ι

22 So I went to jail, 11 days, and lost everything. It 23 was on a truancy, they was trying to put her in jail, but I was 24 still in her custody.

And it was after that that I got in trouble and I went

1	to treatment Thunderbird.
2	But, man, I, I don't know why I thought so highly of
3	being independent, that's just a, kind of watching who my
4	grandpa was, and I just felt I was taking from my little I
5	see them as my brothers and sisters, but they're my little
6	cousins and me and, yeah, I was like, man, I could take care
7	of myself, I shouldn't be here.
8	My grandma used to try to come bring me home and try
9	to give me 10 bucks or something for, go get yourself something
11:04am 10	to eat, come home, son. And I was like, oh, but I was kind of
11	working, a little yard work and this and that and I was pretty
12	good at logging at that time.
13	And so I give her some money and after awhile she
14	didn't have it, she started hitting me up.
15	Well, man, I just, I don't know, it kind of hurt. I
16	seen a lot of the people I used to hang with trying to grow up
17	and that's, that's awesome.
18	Some of the people that don't, as you seen how, it
19	just seemed really ended up just like me.
11:04am 20	Um, man, I actually loved that woman that was, went
21	through so much, had to remember so many addresses to write me,
22	and just was always there.
23	And I kind of felt like I was, I was failing her, you
24	know what I mean? Like she has a couple kids of her own, and
25	I'm not helping provide.

1	Me, I can't go get a steady job. Me, I man, that's
2	like, okay, but I could, but I could go fish and make lot of
3	money, I mean a lot. I some places pays 10 bucks a pound and
4	it's a 10-pound fish get you almost a hundred bucks. And, man,
5	I was really good at that.
6	But I couldn't do that without I mean, tribal
7	patrols, I mean, they're all over. So, kind of getting chased a
8	lot, away from a lot of work for my own stupidity.
9	Because I don't want to be around here. They put me
11:05am 10	out on Sprague which is, well, the stroll, I mean, the strip.
11	And, man, I'm seeing zombies walk by me every day and, man, I
12	didn't like that. And, I mean, like that was some pretty heavy
13	triggers there.
14	Um, for the most part, yeah, I didn't get high or get
15	drunk. When I got home I was just kind of like, wow, that's,
16	I'm shacked up, you know what I mean? So that was awesome.
17	I mean, I see I got to pay for that, for running off,
18	you know what I mean? To me, I could try to do better. I could
19	try to give it everything I got when I get out.
11:06am 20	I mean, I'm very happy for the time I got to spend
21	with that woman.
22	I don't know if I could try to go back to approach
23	that until I got my life together. And, um, it's hard to see
24	what it could be and not have it for so many years, um, yeah,
	what it could be and not have it for so many years, um, year,
25	um, I could give it everything I got. But, yeah, my heart is, I
25	

1 want to go home. 2 THE COURT: I get that, but I think that you are assuming that having a job and providing and providing for 3 4 Marcella and her kids is the most important thing. That's what you value. That is what you have set up. 5 6 But I don't know Marcella -- obviously I don't know 7 Marcella -- but I can tell you, being around somebody who is 8 drunk, or high on drugs, is not pleasant. 9 So if in fact -- even if you were bringing in stuff --**11:07am**10 and what on earth were you doing with a ceiling fan, you know? MR. CLOUD: You actually got to, I, um, I wasn't, I 11 12 was not actually the one with the ceiling fan. 13 They, the description, we were, it was close, but I was walking down Fort Road, it's a main strip, main road, but it 14 15 wasn't me carrying a fan. 16 I was walking, I was in the vicinity, so they pulled 17 me over and I was drunk. And I matched the description, except we had different colored hats. I had a camouflaged hat and his 18 19 was a blue one. And what was it? Um, kind of common clothes, **11:08am**20 blue jeans and a black shirt. But we had different color stocking caps and mine is clearly camo, but, yeah. 21 22 THE COURT: Still. 23 MR. CLOUD: I, that was, that was actually not me with 24 the ceiling fan. I was just in the general area. So I got --25 THE COURT: Okay.

1 MR. CLOUD: But that was not me. 2 THE COURT: Well I'm glad to hear that, because --MR. CLOUD: I, I, yeah, I, I got left on the side of 3 4 the road by my partner when I was using the restroom. 5 THE COURT: So think about it a little bit. I mean, 6 what do you think Marcella or have you asked Marcella what she 7 would prefer? 8 Would she prefer having somebody who is working his 9 tail off to provide for her, but comes home, is drunk or is, you know, using drugs -- periodically, periodically, if not all the **11:08am**10 time, periodically -- and then is going to get picked up and 11 12 thrown in tribal jail or Federal Court or whatever, because you 13 have a lot of history with the tribe there and a lot of history in Yakima and, quite frankly, a lot of history with Federal 14 15 Court. Or would she like somebody who has his act together, 16 who had to pull it together, who is done with alcohol, who is 17 done with drugs and even if it's an investment of three months, 18 19 can actually get a decent job, hold it, and not be in fear of **11:09am**20 getting a driver's license because, you know, there's not going to be warrants out. 21 22 Is that going to be easy? No. But I think you are 23 assuming what Marcella wants and I don't think that's fair to 24 Marcella. 25 If it is what Marcella wants, if she wants, yeah, I

1	want all that money for a short amount of time, then I don't
2	care whether James goes away for 15 years, which is what you
3	keep edging on in Federal Court, you know? It's what I pulled
4	you back from before.
5	MR. CLOUD: Yeah.
6	THE COURT: But one more, you know, go around, and
7	it's statutory, you're off for 15 years.
8	So, here's what I want to do:
9	I told you I'm going to put you three months after
11:10am 10	your state sentence and I'm going to put supervised release on
11	it.
12	But here's the deal. If, as your finishing your state
13	sentence you're still going to have to do the three months
14	federal you don't want our help, you don't want treatment,
15	you don't want Chris to jump through those hoops to get you
16	health care so that you can get into Thunderbird and get sober
17	and learn some tools and learn some skills, and figure out how
18	to stay sober, then you petition me and I'll cut the supervised
19	release and I'll give you the three months and you'll be done.
11:11am 20	But I won't be able to help you, Chris won't be able
21	to help you. But if you want our help, then at the end of your
22	state time, you just let us help you.
23	And what would happen is we would coordinate with
24	Sea-Tac, we would get a case manager involved, we would try to
25	get everything in place, so that we could give you long-term

1	treatment.
2	You know, I don't know what to say about Marcella, but
3	I've been married 46 years, I sure as hell wouldn't put up with
4	a jerk who was periodically drunk or on drugs. There's no way I
5	would do that.
6	MR. CLOUD: She, she actually doesn't allow it in her
7	house.
8	THE COURT: Then ask her. Talk to her. Find out
9	whether she would invest another three months or so of your
11:12am 10	being in treatment, so that you could be really the guy you
11	should be.
12	You know, one of, one of the other things, you really
13	get ticked off I told you this before you get ticked off
14	about certain things and they're not bad things you get ticked
15	off about, you get ticked off about observing bullies and you
16	kind of, you know, I even think of you as kind of a super hero,
17	who wants to zip in and, you know, make it good.
18	Well, you got to have the tools to make it good and
19	you have to get rid of some of the, you know, hassles, some of
11:12am 20	the addictions to make it good.
21	So she doesn't allow it in her house. How long have
22	you are you going to be able to battle that addiction by
23	yourself, when things get frustrating?
24	Other people have, over the years, learned and I
25	have two kids I have a son who is just about your age. When

1	he has done stupid things and believe me he's done plenty of
2	stupid things he has to face up to them, has to figure out a
3	way to work around them.
4	I have a lot of power. I didn't, I wasn't just given
5	that power. I earned it. It wasn't all that easy. You know,
6	you and I are very dissimilar in some ways, not so dissimilar.
7	But you have to get your act together.
8	And you're running out of chances and I am offering to
9	share some of the immense power that I have with you.
11:13am 10	Either to allow you to get treatment and that's not
11	going to be easy in the new America. You know, where we're
12	cancelling all sorts of health benefits and where we're doing it
13	with all sorts of problems but I have that opportunity to
14	provide that for you.
15	But if you don't want it, I'm not going to make Chris
16	Heinen jump through those hoops. I'm not going to ruin your
17	life. It's your life. It really, you know, in the final
18	analysis, I can't make you sober, I can't make you improve
19	yourself.
11:14am 20	I do think you can do it. Chris thinks you can do it.
21	But you have to believe you can do it.
22	So if you think you've been a failure for not pulling
23	in money, really, who you have to not disappoint, no matter how
24	great Marcella is, you have to not disappoint yourself. You
25	have to decide what it is you want.

1	And so the reason why I am leaving this as a decision
2	for you at the end of state time is you're going to be sitting
3	behind bars and think about that.
4	Do you ever want to spend another year or another 18
5	months or whatever it is, behind bars.
6	Or do you want to have the freedom to be able to go
7	hunt when you want, to visit with Marcella when you want. It's
8	like an investment in yourself and an investment in the
9	relationship with Marcella.

11	to do it.
12	So that's my sentence. I don't care what the

14	If you feel a need to say something, Mr. Rubin, go
15	ahead.
16	MR. RUBIN: Your Honor, may I have one moment to
17	discuss with Mr. Cloud, just one second, please?
18	THE COURT: All right.
19	(Discussion with defendant and attorney off the
11:15am 20	record.)
21	MR. RUBIN: Your Honor, I have, I have, I just wanted
22	to make sure Mr. Cloud was clear on what you had suggested and
23	we are in full agreement with your recommendation or your
24	sentence, Your Honor.
25	THE COURT: Mr. Herzog, any comments?

1	MR. HERZOG: Just a matter of clarification, on the
2	imposition of supervised release at the end of the three months,
3	I think the Court has to impose a term of some kind.
4	THE COURT: Yeah. I'm getting there.
5	MR. HERZOG: Oh, pardon me.
6	THE COURT: So you are sentenced to three months of
7	incarceration to be consecutive to your state sentence.
8	So we're going to have you under federal control for
9	three months.

11	preferably at the beginning of that three months say, no, I
12	just want to get out, I don't care, I'm going to slog through
13	this by myself, I don't need help, I don't need training, I
14	don't need substance abuse, I don't need Chris batting for me, I

16	of here.
