--PERCENTAGE TRIBES WILL PAY THE STATE OF OKLAHOMA ON THEIR ADJUSTED GROSS REVENUE (THE TOTAL RECEIPTS RECEIVED FROM THE PLAY OF ALL GAMES MINUS ALL MONETARY PAYOFFS)

- 1. 4% ON THE 1ST 10 MILLION (\$1-\$10,000,000)**
- 2. 5% ON THE NEXT 10 MILLION (\$10,000,001-\$20,000,000)**
- 3. 6% THEREAFTER (\$20,000,001 & ABOVE)**

QUARTER HORSE, THOROUGHBRED & PAINT &

- 1. 30% TO THE OKLAHOMA TAX COMMISSION**
- 2. 20% WITH 10% DISTRIBUTED TO THE HORSE
RACING COMMISSION/OK BREEDING
DEVELOPMENT FUND, AND 10% DEDICATED TO
QUARTER HORSE, THOROUGHBRED & PAINT &
APPALOOSA HORSE RACES**
- 3. 50% SHALL BE RETAINED BY THE
ORGANIZATION LICENSEE**
